**DISASTER & EMERGENCY PLAN  
MASARYKTOWN FIELD TRIAL GROUNDS**

**CALL 911 for MEDICAL or LIFE or PROPERTY THREATENING SITUATIONS and state the nature of the emergency.**

Directions for emergency personnel:

- The location is in north Pasco County, 2.9 miles south of the Hernando-Pasco County Line Road on US Highway 41.
- Enter through the gate located about 150 feet south of the mailbox at 16354 US Highway 41 South. The gate and the mailbox are on the west side of the highway.
- Proceed about nine-tenths of a mile into the property to the sand hill area... (add any further description to the location where help is needed.)

- If possible, send someone to the entry gate to guide emergency personnel into the property.

Call 800-854-2862 or 727-844-7711, Pasco County sheriff, for non-medical or other non-emergency assistance.

**CLOSEST HOSPITAL:** Spring Hill Regional Hospital (352) 688-8200.

- From the property gate, go 2.9 miles north on US Highway 41 to County Line Road.
- Turn left on County Line Road.
- Go approximately 6 miles to the traffic light at Mariner.
- Turn right, the hospital is on the right at 10461 Quality Drive.

**VETERINARIAN:** County Line Animal Hospital. 727-856-4485, 352-799-1025.

- M-F 8 AM to 5 PM, Thursdays until 7 PM, Saturday 8-12.
- After hours emergency number : 727-841-6575.

- From the property gate, go 2.9 miles north on US Highway 41 to County Line Road. Turn left on County Line Road. Go approximately 6.5 miles; the vet is at 15240 County Line Road.

**ANIMAL EMERGENCY OF HERNANDO:** 352-666-0904.

- Night and major holidays 5:30 PM to 8 AM. Week-ends Saturday 8 AM to Monday 8 AM.
- From the property gate, go 2.9 miles north on US highway 41 to County Line Road, turn left on County Line Road.
- Go approximately 6 miles to the traffic light at Mariner.
- Turn right and go to Spring Hill Blvd.
- Turn left on Spring Hill Blvd. Go approximately 3 miles to Deltona Blvd.
- Turn Right. The Animal Emergency Clinic is at 3496 Deltona Blvd.

**DIRECTIONS:**

From the South, take I-75 and exit at S. R. 52. Go West on S. R. 52 to U. S. Hwy. 41 and make a right (North) on U. S. 41. Go approximately 5.5 miles and make a left at Field Event sign in front of the gate. (Nearest mail box to gate is at 16354 U. S. 41). Follow Dog Grounds and Field Event signs approximately 1 mile into the property to the main camp site.

From the North, take I-75 and exit S. R. 50. Go West on S. R. 50 to U. S. 41. Go South on U. S. 41 approximately 11 miles and turn right at the Field Event sign in front of the gate. (Nearest mail box to gate is at 16354 U. S. 41). Follow Dog Grounds and Field Event signs approximately 1 mile into the property to the main camp site.

The grounds will be open for the weekend about 3 p.m. Thursday before the event.

**CAMPING:**

Camping is allowed on the Masaryktown Field Grounds. No electric hookups are available. Water is available on the grounds. An outdoor hot water shower is available. For more information on the grounds, please call Len Hutto at (407) 322-8028.

Al Luther is across the street from the grounds and may have space for camping. Stalls, hot showers and full hook ups available. Call Al Luther at 352-799-0979 (1/4 mile north of the grounds on US41)

**AREA MOTELS:** The closest hotels are in Brooksville and Spring Hill, ask about dogs.

**BREAKFAST:** Coffee and doughnuts will be furnished by the club each morning.  
**LUNCH:** Lunch will be available both days free with each entry, all others \$5.00  
**DINNER:** A pitch in dinner will be held on Saturday night. Bring a covered dish to share and the meat of your choice to grill for yourself. We will build a fire and have space available on the grill.

Excessive drinking will not be tolerated. Please do not drink and drive.

**We are guests on this property. Please observe the following guidelines so that the owners of the Masaryktown Field Trial properties will continue to permit us to use these grounds!**

If your dogs, horses, other family members or guests dig holes, you are expected to refill them before you leave. You are expected to pick up around your campsites. Please do not put trash on the ground, proper trash containers are available.

If you cook out on your own, be sure to keep your fire under control. Be sure your fire is completely out when you leave and your fire pit is completely covered. SAFETY COMES FIRST!!!

Please respect your fellow campers and keep noise to a minimum at night. Others may have to be up very early the next morning to run a dog.

Keep motor vehicles on the obvious roadways. Do not drive across our fields.
